Interested vendors must respond on time, and clearly show: (1) they can provide services within the catchment area with a facility available for use, (2) such services will be provided by a professional meeting the criteria required, (3) they can provide all services, including local services, as identified in Section B of the RFP, and (4) prices of such treatment shall be as low or lower than those charged the vendor's most favored customer for comparable quantities under similar terms and conditions.

Request for Proposals (RFPs) should be submitted electronically. **DEADLINE FOR COMPLETED RFPs, with the exception of Residential Treatment and services in Will County, is JUNE 30, 2025 @ 4:30 p.m. Will County and Residential Treatment deadlines are July 3, 2025 @ 4:30pm.** Late RFPs **WILL NOT** be accepted.

Interested treatment providers should submit a letter of interest to the NDIL treatment services solicitation email address [ILNPml\\_TVS@ilnp.uscourts.gov](mailto:ILNPml_TVS@ilnp.uscourts.gov). Interested providers will receive e-mail notification when the RFPs have been posted to this website, generally on or about June 3, 2025. If the RFPs are not posted by this date, please

frequently check the web page for the posting. For Drug Testing Collection Providers, the Department of Labor wage determination will also be available on this web page.
